2017 NATIONAL FINALS RODEO SWEEPSTAKES OFFICIAL RULES

- 3. DEADLINE: Online entries must be received between 12:01 a.m. Central Standard Time on July 1, 2017, and 11:59 p.m. Central Standard Time on October 13, 2017 (the "Entry Period").
- 4. LIMIT OF ONE ENTRY PER PERSON. Only one entry is permitted per person. This means that you, personally, can only enter once per Entry Period.
