## 2021 NATIONAL FINALS RODEO SWEEPSTAKES OFFICIAL RULES

- 3. DEADLINE: Online entries must be received between 12:01 a.m. Central Standard Time on July 1, 2021, and 11:59 p.m. Central Standard Time on September 30, 2021 (the "Entry Period").
- 4. LIMIT OF ONE ENTRY PER PERSON. Only one entry is permitted per person. This means that you, personally, can only enter once per Entry Period. You may not register multiple times using different e-mail addresses. If you attempt to register more than once, only the first entry will be considered and subsequent entries will be disqualified.
