

Stoecklein Photography Western Photo Workshop Giveaway

OFFICIAL RULES

NO PURCHASE REQUIRED. BUYING WILL NOT HELP YOU WIN. YOUR CHANCES OF WINNING WITHOUT MAKING A PURCHASE ARE THE SAME AS THE CHANCES OF SOMEONE WHO PURCHASES SOMETHING. IT IS ILLEGAL TO GIVE ANY ADVANTAGE TO BUYERS IN A GIVEAWAY.

1. ADMINISTRATOR AND SPONSORS: The Giveaway (defined below) is run by USFRSC, LLC. dba Cowboys & Indians (“Administrator”), 12801 N. Central Expressway, Suite 565, Dallas, TX 75243. The sponsors of the Giveaway are Cowboys & Indians, Stoecklein Photography, and Roper Apparel & Footwear.

2. ENTRY: To enter the Stoecklein Photography Western Photo Workshop Giveaway (the “Giveaway”) online, go to www.cowboysindians.com/stoecklein, follow all entry instructions, and complete and submit the online entry form.

NO PURCHASE NECESSARY TO ENTER OR WIN. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator. Void where prohibited by law.

3. DEADLINE: Contest giveaway begins April 8, 2024, and ends July 21, 2024 (the “Entry Period”).

4. LIMIT OF ONE ENTRY PER PERSON. Only one entry is permitted per person. This means that you, personally, can only enter once per Entry Period. You may not register multiple times using different email addresses. If you attempt to register more than once, only the first entry will be considered and subsequent entries will be disqualified.

Entries will be made by the authorized email account holder of the email address submitted at the time of entry.
